- Ensure a stable internet connection and conduct a pre-test of your audio-video settings in advance to minimize potential technical disruptions.
- Dress professionally, adhering to the Lloyd Uniform, to maintain the decorum of the competition as one would for an in-person interview.
- The interview panel will comprise members from the Lloyd Legal Aid Cell administration and official mentors of the society.
- Once participants have been assigned a specific date and time, please be advised that changes will not be accommodated for any reason. Plan accordingly to ensure your availability.
- Please be informed that failure to appear for the interview rounds shall result in disqualification from the elimination rounds. No reasons shall be entertained for whatsoever reasons.
- The selection to the Lloyd Legal Aid and Services Clinic shall be based on the interview
- The scheduling of interview rounds is contingent upon the official members' availability, and adjustments to either advance or defer the process can be accommodated accordingly.
