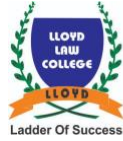

Date & Venue ::

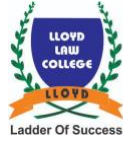
The competition shall take place from **Saturday 18 - Sunday 19 May 2024** at Lloyd School of Law (Campus 02).

Eligibility ::

The competition is open for all the bona fide students of **all the batches of Lloyd Law College and Lloyd School of Law studying in LL.B, B.Com.LL.B., and B.A.LL.B.**

Awards & Prizes ::

Winner :: Cash Prize of INR 21,000/- (Twenty one thousand only), title of 'Best Mooter of Lloyd' along with a trophy and certificate of merit. The team will be allocated to a highly-reputed Moot Court Competition.



Runner up :: Cash Prize of INR 16,000/- (Sixteen thousand only) along with a trophy and certificate of merit. The team will be allocated to a highly-reputed Moot Court Competition.

Each member of the teams qualifying for the octa-finals shall be awarded membership of the Lloyd Moot Court Society. Additionally, apart from the members of the team qualifying for the octa-finals, participants securing top-50 rank (the number might change depending upon the total number of participants) based on total speaker scores in preliminary rounds shall be awarded the membership of Lloyd Moot Court Society.
