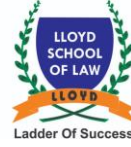
Format of the Competition:

Topic:

The topic of the debate is:

Rules:

1. The speaking time for each participant shall be 3 minutes with no interjections.
2. The participants are allowed the use of either Hindi / English language.
3. The results will be based on the evaluation of the marks however the final discretion lies within the authorities.
4. The speakers can choose to speak either FOR or AGAINST.

Note:

1. All the participants are requested to stay back after 3.00 P.M. to participate in the competition and should bear in mind that no additional transportation will be provided by the college for the same.
2. After the selection process and announcement of results, the selected members are obligated to attend the regular sessions and maintain their attendance in the society, debating and deliberating.
3. The selected members will not be allowed to participate in any programmes of any other society unless they maintain a 75% attendance in the regular sessions.



4. It is also mandatory for all the selected members to participate in at least 5 competitions after their induction, to remain an active member of the society.

Hope to see you all in regular classes, additional courses, enjoying practical academics, skilling opportunities and professional guidance of excellence and standard.
