

Convocation Ceremony :: BA.LL.B. (2015-20) & LL.B. (2017-20)

This day has a profound memory of our Guru and Guide Padma Bhushan Late Prof. (Dr.) N. R. Madhva Menon. Hon'ble Mr. Justice Rajesh Bindal, Judge, Supreme Court of India, is the Chief Guest and Dr. Lalit Bhasin, President SILF and BAI is the "Guests of Honour" of the event. There will be other distinguished guests from the Bench and the Bar of the Supreme Court of India.

Mandatory Attendance :: BA.LL.B. (2019-24), BA.LL.B. (2018-23) & LL.B. (2022-25)





Convocation is one of the most important day in the life of a student. This is most celebrated day in the law school. Walking in tense and bare handed and walking out happy and with the graduation degrees.

It is mandatory on every student of BA.LL.B. (2019-24), BA.LL.B. (2018-23) & LL.B. (2022-25) to attend and witness the Convocation Ceremony on Sunday 07 May 2023, IST 09 AM, Auditorium, Lloyd School of Law. One full day PRESENCE / ABSENCE will be marked for all the attendees & Non-Attendees. There will be Non-Instructional Off for Monday for all the batches having regular classes in the Weekdays in the campus.

It is mandatory on all the students of Moot Court Society, LIMA, DebSoc, Anchoring Team of 2023 to attend and witness the Convocation Ceremony on Sunday 07 May 2023, IST 09 AM, Auditorium, Lloyd School of Law. One full day PRESENCE / ABSENCE will be marked for all the attendees & Non-Attendees.

**Dress Code :: Lloyd Uniform** 

Transportation :: All Delhi - NCR buses and Hostel Buses will ply for the day.

#### **General Instructions::**

- 1. No one is allowed to use mobile phones and cameras inside the Graduation and Recognition Day ceremony venue for photography or videography.
- 2. Professional Photographer has been arranged by the institution for taking photographs during the ceremony.
- 3. On the Procession entering the Hall, the candidates and the audience shall stand and remain standing until the members of the procession have taken their seats.
- 4. Graduands will be guided by a faculty and volunteers while receiving the degree from the Chief Guest. After receiving the degree, Graduands should return to their respective seats, through specific aisle.
- 5. When the graduation ceremony is over, all the students should stand up in their places and remain so while the National Anthem is being played and until the academic procession leaves the Auditorium.
- 6. No one is allowed to leave the Auditorium before the Academic Procession leaves the Auditorium
- 7. Lunch will be served at Mess from 12:30 P.M. onwards.

#### **Decorum / Conduct & Discipline Guidelines ::**

- 1. Convocation Ceremony requires complete decorum.
- 2. No cross talks, photography, movements, loitering inside the convocation hall are allowed during the ceremony.
- 3. During the function the audience will keep sitting in their seats and will not move out of their seats.
- 4. On being called for receiving the degree, the awardee members and students should alight the stage and walk to the dais from one end in a dignified and orderly fashion in sequence of their names called to receive his/her certificate at the hands of the dignitaries and come back to his/her allotted seat from the other end of the dais in an orderly sequential fashion. They should not huddle/jostle on the stage.





- 5. Protocol for VIPs shall be followed in accordance with the Government guidelines.
- 6. The following items are prohibited during the ceremony: camera, whistles, bottled water or any bottled liquids, balloons, wrapped gifts, weapons, knife, sharp objects, food, alcohol etc.
- 7. Bring one photo ID proof (Passport, Voter I-card, Aadhaar card, Driving License, College I-card, PAN card etc.) for registration at the venue and for allowing entry into the convocation hall.
- 8. Coats, trousers, purses and other items are subject to inspection.
- 9. Vehicles shall be parked in assigned parking area only.
- 10. A "Stole/Uttariya", shall be issued to the members permanently at the time of registration, which they would have to wear around their neck and shoulders.
- 11. Awardee members and students must sit only at the allotted seat in the convocation hall.
- 12. Seats shall be occupied by the members/students ONE HOUR before the start of function.
- 13. The audience present in the Ceremony shall stand up at the following occasions:
  - At the time when the academic procession enters the hall and till they take their seats,
  - At the time of the Invocation (Saraswati/Ganesha Vandana),
  - At the time of national anthem
  - At the time when the academic procession departs and leaves the hall.
  - At the time of administering the "Oath".
- 14. During the function mobile phones should be kept switched off.
- 15. The clapping of hands is the only form of acknowledgement recommended.
- 16. Whistling, shouting, making noise, cheering and other forms of exclamations are prohibited.
- 17. No one should crowd in front of the dais and in the aisles.
- 18. Breach of protocol may lead to legal punishment and disciplinary action.
- 19. Members and students are allowed to participate in the Convocation subject to confirming his / her participation.
