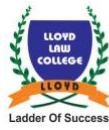

Hon'ble Mr. Justice S. Ravindra Bhat was born in Mysore, Karnataka on 21 October 1958. Justice Bhat did his B.A. (Hons.) in English from Hindu College, University of Delhi and obtained LL.B. degree from the Campus Law Centre, Faculty of Law, University of Delhi, in 1982. He enrolled as an Advocate with the Delhi Bar Council in 1982 and practiced in the Supreme Court, where he was enrolled as an Advocate on Record in 1989. Justice Bhat practiced in Public Law, Employment, Education and Constitutional Disputes and appeared in several important cases before the Constitution Benches of the Supreme Court during his legal career. He was appointed as an Additional Judge of the Delhi High Court on 16 July, 2004 and as a Permanent Judge on 20 February, 2006 where he also became India's first high court level judge to hold the e-court at the Delhi High Court. He was further appointed as the Chief Justice of the High Court of Rajasthan on 05 May, 2019 and subsequently elevated as a Judge of the Supreme Court of India on 23 September 2019. In his tenure as a judge of the Delhi High Court, Justice Bhat delivered some landmark judgements, particularly in the field of IPR, drug regulation and right to information. Another significant judgment from his table is CPIO v. Subhash Chandra Agarwal in which he held that the office of the Chief Justice of India is amenable to the provisions of the Right to Information Act.
