#### **ONLINE LINK AND THE PROCESS:**

2. Click on "Affiliated College" to proceed
3. Fill in your details under the column "Student's Details"
4. Fill in your parent's/guardian's details under the column "Parent / Guardian Details"
5. Fill in the "College and Course Details" as per the following;

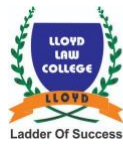

6. Tick all the boxes under the "UGC Regulations" column
7. Fill in the "Confidential Survey", fill 18001805522 as "Phone number of National Anti-Ragging Help Line"
8. Click on "I have rechecked the form and confirm that all the details are correct."
9. Click the "Submit" button.

Once you have completed **Step 09** as stated above, a Reference No. will appear on the screen. Note down your Ref ID before proceeding to the next step. **If you do not note down the Reference No., it will not appear again and you will not be able to complete the process.**

10. Click on the tab "Forms" (4<sup>th</sup> Tab from top right corner of the same page which is displaying Ref No.)
11. Go to "Download Undertaking" (2nd in the drop down under "Forms" Tab)
12. Fill in your Reference No., mail ID and mobile no. (as filled in the Undertaking)
13. Click on Submit and you will get a pdf of your filled in undertaking.
14. **The Final Step:** The downloaded pdf **has to be compulsorily uploaded** in your college ERP under the Tab "Anti-Ragging Undertaking".

**The College shall NOT verify the End Term University Odd Semester Examination Forms of such students who do not complete the process. Failure to appear in the examination due to this reason shall be the sole responsibility of the student.**
