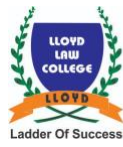
Interested students may fill the google form below and the selected students will be communicated via email latest by Saturday 27 January 2023;

A few important points to consider:

1. **Deadline:** The google form will be available only till **27 January 2024** and no applications will be considered after this period.
2. **Eligibility:** B.Com.LL.B. & B.A.LL.B. (2021-26) (2020-25) and LL.B. (2023-26) & (2022-25) are eligible to join the CLPC.
3. **Number of seats:** We have a limited number of seats for the cell and the total number is capped at 100.
4. **Attendance:** Attendance is mandatory for all the sessions / workshops / lectures which are organised by the cell. The students will be removed from the cell if found to be non-adhering to this rule.
5. The courses and guest lectures will be held only over the weekend i.e. Saturday & Sunday.
6. Preference would be given to students who demonstrate genuine interest in the areas of corporate law.

As the first initiative for the upcoming semester, CLPC is conducting the certificate course on PE/VC and Competition laws for the months of February and March 2024 and the course curriculum for these certificate courses are attached. This shall be followed by courses on



capital markets, intellectual property law, contract law and others. Each course shall be assessed through various assessment exercises tailored to each course and the best performing students will be offered internship opportunities with law firms. Course details attached with the mail.
