- I.** This record has not considered any exemption, including exemption in case of internship, granted to you;
 - Exemption shall be considered in the attendance record during last month of this semester; and attendance in lieu of exemption will be granted, provided, all the rules on the same were complied with;
- II.** No attendance shall be granted on medical grounds / family exigency / similar other instances;



- III.** In case of any grievance on the ATTENDANCE RECORD as shared with this email, kindly write email to the Faculty In-charge (Attendance) of your Section / Batch within 02 days (including non-working days) of receiving this email;

 - List of the Faculty In-charge (Attendance) is attached with this email for your reference;
 - Meet the Faculty In-charge (Attendance) between 03 pm - 04 pm, only after writing the email;
 - This redressal communication, writing email + meeting the Faculty In-charge (Attendance), must be completed within 02 days of receiving this email;
- IV.** All the grievances will be settled within 02 working days of receiving the grievance; once all the grievances have been settled, we will share the FINAL ATTENDANCE RECORD for the given duration that will be final.
- V.** No further concern / issue / grievance on the attendance will be entertained once attendance records are finalized and have been shared with the students / parents;
- VI.** All the parents are welcomed to meet Dr. Akhilesh Kumar Khan (Director - Admission & Administration) if they have any concern on the subject matter of attendance of their ward;
- VII.** Parents of students having 50% or less than 50% attendance are invited to meet Dr. Akhilesh Kumar Khan (Director- Admission & Administration) within one week of receiving this email;
- Parents are requested to ensure that they are meeting Dr. Akhilesh Kumar Khan as it will help them as well as the college to take correctional steps for attaining better attendance record of such students;
- VIII.** Dr. Akhilesh kumar Khan will be available between 02 pm - 05 pm at his office in Campus 02;
- IX.** Students with less than 75% will not be allowed to appear in the term-end examination conducted by the CCS University, Meerut;
- Kindly take notice of the fact that, in the immediate previous semester (examination conducted during June/July, 2023) total 186 students had failed to appear in their respective term-end examination for reason of not complying with attendance rules.
