With immense pleasure to communicate that, Lloyd Law College is declared as the host for the South Asia Regional Rounds of this prestigious competition. One team consisting of 03-05 members will be constituted to represent Lloyd in this prestigious competition in South Asia Rounds and if the team qualifies as per the competition rules, will be representing Lloyd / India in the Global Oral Rounds in Germany. Hence, we require total commitment from each and every team member for the whole year of 2024. In South Asia & Global Rounds, all the expenses of registration, travel and accommodation will be undertaken by Lloyd as per policy.

Foreign Direct Investment International Arbitration Moot, 22-25 Aug. 2024 :: The FDI Moot is a competition for law students to foster the study and practice of international investment arbitration. Students from all countries are eligible (students from across the globe participate in regional and global rounds). Your participation in these moot court competitions will not only enhance your legal skills but also provide you with an invaluable experience of real-world legal proceedings. As per the notification their website;

*"Participation in the 2024 Globals is based on **in-person attendance**. Team members needing visas are encouraged to start their applications at least 03 months in advance. A team may apply for the in-person requirement to be waived on grounds such as visa, health & safety, or financial restrictions. The application deadline (for Globals in Germany) is **01 September**: [Application Form](#). Waiver entails the virtual participation of the entire team.*

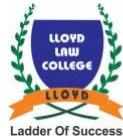

SELECTION PROCESS :: FDI, 2024 Open Challenger Rounds

Eligibility & Registration Process ::

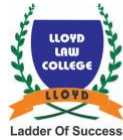
1. The participation, selection and team formation is open to all the students of Lloyd Law College & Lloyd School of Law studying in any of the mentioned **batches of B.A.LL.B. or B.Com.LL.B. (2020-25), (2021-26), (2022-27) and LL.B. (2023-26), (2022-25)**. A team can be formed across the batches.
2. Registration and participation in the Open challenger is free of cost. Participants are not allowed to use the college campus printing and computer systems facility.



3. This event is **NOT** open to B.A.LL.B. (2019-24), (2023-28) and LL.B. (2021-24).
4. A team of two person is to register latest by or before **Saturday 20th Jan. 2024, IST 08 PM** by sending mail to fdi24@lloydlawcollege.edu.in , mentioning the following details;
 - a. Team Name
 - b. Batch & Section
 - c. List of Moots/ADR/Debate Competitions participated
 - d. Moots/ADR/Debate Competitions Achievements
5. We will provide code to each team on registration a day before the submission of first memorial.
6. No two memorials of two different participating teams should be similar, in case of similarity, the team that has submitted the memorial prior/first in time in email to fdi24@lloydlawcollege.edu.in will be allowed to participate and the other team will be adjudged / eliminated / barred from the Open Challenger on the ground of plagiarism / academic theft. We will not invite any hearing for excuses on the same. That is why we have abstained the participants from the use of college campus printing and computer systems facility.

Memorial Submission :: 200 Marks (100 Claimant, 100 Respondent)

1. The **FDI, 2024 Competition Moot Problem** is released now as attached herewith, the same problem will work as the problem for the FDI, 24 Open Challenger and Selection Rounds at Lloyd.
2. All submission rules of word count, font kind and font size, spacing, paging, formatting, footnoting, referencing etc. will remain the same as per the FDI, 2024 Rules mentioned in the notification on their website. **FDI 2023 Rules** are attached herewith for the same.
3. Memorial Marking will be done as mentioned above, 200 Marks (100 Claimant, 100 Respondent), the same will be added to the Final Score with Oral Score in result formation for the Selection of Team/Member.
4. Each participating team shall be drafting the skeleton memorial from both (Claimant & Respondent) sides and to submit as on following date;
 - a. **Submission of Claimant Skeleton Memorial :: Monday 28 Jan. 2024, IST 08 AM**
 - b. **Submission of Respondent Skeleton Memorial :: Friday 02 Feb. 2024, IST 08 PM**
5. All submission and communications will be done to fdi24@lloydlawcollege.edu.in
6. The same skeleton memorials that are submitted as on deadlines, Teams have to submit hard copies of the 02 sets of skeleton memorials from both sides to the Office of Senior Director & Dean, Lloyd Law College & Lloyd School of Law latest by :: **Sunday 04 Feb. 2024, IST 09 AM**



Oral Pleadings :: Each Team Member 100 Marks (50 Claimant, 50 Respondent)

1. There will be Oral Pleading Rounds for all the participating teams from both Claimant and Respondent Sides.
2. 20-25 minutes is the minimum – maximum time of pleading for one side.
3. Each member will be marked separately in Oral Rounds. In case, one team member back out of the selection rounds, 01 member has to plead all issues in both rounds and will be marked accordingly.
4. **There will be in-person oral rounds in the Lloyd campus on Sunday 04 Feb. 2024, IST 09 AM. No online oral round requests will be accepted.**

FDI, 24 Open Challenger :: Result :: Monday 05 Feb. 2024, IST 04 PM

Result will be made and declared for all. Selection from the open challenger will be made on the basis of top 03-06 highest scoring individuals. Highest score will be calculated from Memorial Score added in the Oral Round Score.

FDI, 24 Team Meeting 01 :: Tuesday 06 Feb. 2024, IST 03 PM

The team will start working in-campus from Tuesday 06 Feb. 2024, IST 03 pm onwards without any excuse and failure.
