 - iii.** Identifying research universe of respondents
 - iv.** Sampling process
 - v.** Administering the tools
- VI. Presentation of data**
 - i.** Tabulization & interpretation
 - ii.** Writing findings, & Testing of hypotheses
 - iii.** Writing conclusion (*conclusion on research questions*)
- VII. Writing concluding part of the paper, including suggestions**

2. Research tool (Interview-Schedule) has been shared here for your purposes;

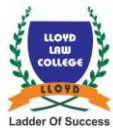
- I.** Use the Interview-Schedule attached here as APPENDIX – III

5. Submission will be taken by the Teacher taking IIIrd lecture on 28th April, 2023



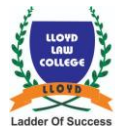
