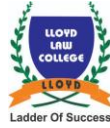

DebSoc's core objectives are:

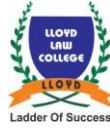
- To facilitate intellectual discourse at Lloyd while maintaining a non-partisan stance.

Roles and Responsibilities

Conveners

- Select diverse and engaging debate topics for the members' practice.
- Coordinate with the teachers or mentors for workshops and coaching.
- Coordinate responsibilities.
- Initiate the organization of intra-college or inter-college debating competitions.

Coordinators

- Maintain records of Debate Society members, tournament attendance, wins, and status.
- Coordinate nominations for upcoming competitions.
- Document sparring sessions, including team details and debate motions.
- Hold office for one academic year or as directed by the authorities.
