Mr. Eshan has been a part of several arbitrations administered by leading institutions like the International Chamber of Commerce, the Singapore International Arbitration Centre etc. as well as various ad hoc tribunals. He appears before various courts across India. His most notable case in his young years of practice is the N.N. Global Mercantile Pvt. Ltd. v. Indo Unique Flame Ltd. case [2023 SCC OnLine SC 495] before a constitutional bench of 5 hon'ble judges, as counsel.

Mr. Eshan is a Hague Scholar (The Hague Academy of International Law, Private International Law, 2020). His areas of interest are Private International Law, Commercial and Investor – State Dispute Settlement, Block chain Technologies Laws, Energy Law and Fashion Tech laws.

Mr. Eshan is particularly also keen on Economics and Cross Border Economic and CISG Transactions.

Mr. Eshan was a British Counsel gold medalist (Germany, 2016-2017) debater before law school. He developed his impeccable interest for mootings while in law school and has an experience of building the Vis moot board at Lloyd by virtue of being its founding member. He has participated (as oralist participant and judge) in moots like, United Nations Development Program Environmental Law Moot (Top 8 teams) FDI International Arbitration moot, 2019 and the 28th, 29th and 30th Willem C. Vis moot while also helping teams from across the globe in competitions like Frankfurt Investment Arbitration, John H. Jackson WTO (ELSA) moot and NLSIAM amongst others.
