- 1. IT IS MANDATORY ON EVERYONE AT ALL TIMES IN THE MOOT COURT SOCIETY, LIMA, DEBSOC, CORPORATE LAW PRACTICE CENTER, LASEC ETC. TO MAINTAIN MINIMUM MANDATORY 75% ATTENDANCE IN THE REGULAR PHYSICAL CLASSES IN THE LAW SCHOOL WITHOUT THE INCLUSION OF ANY EXEMPTIONS.**



2. The Selected Students shall work from 03 PM to 07:00 PM in Campus on class Days and from 09 AM to 07 PM on Non-class Days.
3. The moot is an exclusive opportunity for the residents of the Lloyd's hostel and day scholars only.
4. No exceptions shall be granted to any student from this rule irrespective of any situation or condition. There is no concept of Work from Home in Moot Court Society.
5. The Selected Students shall not become part of any other society and if they are already part of any other society, they shall resign immediately.
