- The Members will be working in different committees like the PR committee, Judges Committee, and Scoring Committee as allotted.

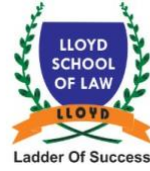
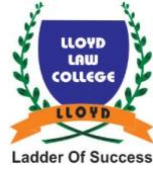
**Requirements ::** Number of members required is 10 (Ten only).
