Mr. Bharat has served as a Partner at L&L Partners (formerly Luthra and Luthra Law Offices)

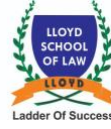
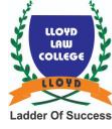

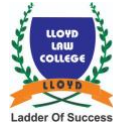
