Greetings From Lloyd Academic Community!

In the academic year 2022-2023, we have participated in more than 130 moots out of which 17 moots were International, and it gives us immense pleasure to announce that we have received 116 awards in this academic year. In the past academic year, we have won 10 Moot Court Competitions, have been adjudged runners-up in 17 moot court competitions, have bagged best memorial award in 7 moot courts, we have won 2nd Best memorial award in 6 competitions, Best speaker award in 7 Moot Court Competitions, 2nd Best Speaker in 4 Moots and many more such achievements.

This year we have taken a step forward and have won the Regional Rounds of Foreign Direct Investment Moot, 2022 and were Quarter Finalists in the World Rounds. This also extends to 3rd Best Memorial in Philip C. Jessup Moot Court Competition 2023. We have also been meritorious in more than 116 moots so far. 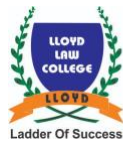
