Greetings from Lloyd Academic Community!

Lloyd Law College follows the policy of skill-based teaching learning and practices the same through various co-curricular activities, like, Lloyd Trial Advocacy Competition. It is an annual intra-college training program for selected students that runs for over six months and is organized every year. This year, i.e., 2022, we are conducting the IVth edition of the LTAC.

The LTAC 4.0 was launched in January, 2022 and a team of selected students were trained on investigation process through workshops. Now, the LTAC has entered into iind stage, i.e., 'framing of charge'. Participating students will argue before the trial court for framing of charge against the accused. This simulation exercise will be conducted on three days, i.e., 10<sup>th</sup>, 11<sup>th</sup>, % 17<sup>th</sup> September, 2022. 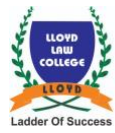
#### **COURTS ::**

Ms. Prachi has graduated from Symbiosis Law School, NOIDA in the year 2018 in B.A. LL.B. and is currently practicing criminal, matrimonial and service laws in the Delhi District Courts, Delhi High Court as well as before the Hon'ble Supreme Court of India for the last four years. She has majorly worked and assisted on briefs pertaining to murder, theft/robbery, terrorism, narcotics, 'sexual offences committed against women & children as well as 'Medical Termination of Pregnancy Act', most of which have been widely reported in the daily newspapers as well as other legal news related fora. Further, she has also assisted in editing the 35th edition of the Ratanlal Dhirajlal's Indian Penal Code, 1860 published by Lexis Nexis and has also judged the Mock Trial Advocacy Competitions in the past.
