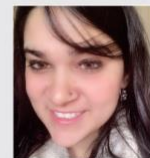

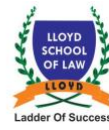

She specializes in dispute resolution including civil, criminal, and matrimonial matters.

Ms. Maini currently serves as a Visiting Faculty for Criminal Laws, Human Rights, Supreme Court Practice & Procedure, Women and Child Laws, Civil Procedure Code and International Crimes at various colleges such as National Law University, Delhi, Maharashtra National Law University Nagpur, Renaissance Institute of Law and Lloyd Law College, Noida.
