Ms. Vasundhra Minocha graduated from Symbiosis Law School, Pune ("SLS") in B&A & LL.B. where she was awarded as the "Best Outgoing Student". During her studies at SLS, she interned with leading law firms like Cyril Amarchand Mangaldas, Jait Singh Associates as well as leading lawyers such as Mr. Rajesh Dhawan. To explore the various other facets of the legal field she also interned at PRS Legislative Research and Nani Polkivola Arbitration Centre. Further, she also volunteered with non-profit organizations such as Transparency International India and Commonwealth Human Rights Initiative.

Ms. Minocha pursued LL.M. from Cornell Law School, Ithaca, New York and was awarded the "CAI Excellence for Future Award" for achieving the highest grade in the "Dispute Resolution Practitioner" course. In 2017, Ms. Minocha joined the Project and project finance practice at Cyril Amarchand Mangaldas, New Delhi, India. As part of the Project and project finance practice, her work entailed assisting and advising domestic as well as foreign clients engaged in various sectors through the life cycle of financing and public-private partnership transactions including structuring, negotiations, due diligence, preparing transaction documentation and "requests for proposal", undertaking pre and post-closing deal related documentation, filings and intimations.

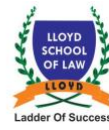
Ms. Minocha worked at Khaitan & Co. from mid-2018-May 2021. She was promoted to senior associate in April 2021. As part of the general corporate practice, her work entailed assisting and advising domestic and foreign clients engaged in various sectors through the life cycle of a deal including (a) structuring, (b) negotiating, (c) due diligence exercise, (d) preparation and finalization of transaction documents, and (e) undertaking pre and post-closing deal related documentation, filings and intimations. Some of the marquee transactions that she had handled inter alia were the sale of the majority shareholding of Aadhar housing finance limited, the acquisition of a shareholding in dunzo digital private limited by a venture capital firm, the acquisition of a shareholding in the parent company of Maharashtra hybrid seeds company private limited by an international financial institution.

Currently, Ms. Vasundhra is a Partner (General Corporate, Merger & Acquisitions, and Private Equity) at Ascendus Law Partners (earlier known as TSA Legal) Partner Ascendus Law Partners. Vasundhra has advised clients on various aspects of corporate law including drafting and negotiating commercial contracts and providing transactional support (undertaking due diligence exercises, drafting and reviewing of investment documents such as share subscription / purchase agreements, business transfer agreements, joint venture agreements, asset purchase agreements, exclusivity and stand-still agreements, and undertaking pre and post-closing deal related documentation, filings and intimations).

As a pro bono activity, Ms. Minocha also prepared the course material for a module of the "Post Graduate Diploma Course in Securities Law" (one-year part time) conducted by Government Law College, Mumbai and assisted Mr. Shradh Abhyankar, partner at Khaitan & Co during the lectures for this module.

Her professional affiliation is with the Bar Council of Delhi (enrolled in 2018) and the New York State Bar Council (enrolled in 2018).
