The Vis East Moot introduces aspectsof international dispute resolution and business law, like commercial investment, businesscontracts, sale of goods, corporate structures & procedures. The Vis East Moot spans approximately five months each year in two phases, written memorials for claimant and respondent due in December and January respectively, and the oral hearings will take place in late March.

**About Frankfurt Investment Arbitration Moot Court ::**

The Frankfurt Investment Arbitration Moot Court is the oldest and most prestigious student competition in the area of investment protection law. Its focus is on the oral presentation of legalarguments before an arbitral tribunal composed of specialists in the field during a one-week finalevent which takes place in early or mid-March of every year.

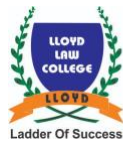
