- If your name is found in two sections / courses, both will be removed, and this will detriment your attendance. There will be ERP based attendance sheet in the classes and online attendance uploading.

### **Odd Semester Online Registration Process ::**

- **STEP 01 ::** Student has to deposit the due fee for the Odd Semester Aug. - Nov. 2024, ONLINE-via-ERP, as per schedule provided here latest by **Tuesday 30 July 2024**.
- **STEP 02 ::** Fill the complete Registration Form as shown in the POP-UP on ERP. This can be filled only after fee deposit. This form will requires completion in respect of;
  - Mandatory filling yours and parents details, Phone / Email with OTP verification.
  - You can choose your Own Sections in a Batch based on the College/School, Batch/Semester, Max. 60 students in one Section, Optional courses etc.
  - **B.A.LL.B./B.Com.LL.B. (2021-26)** Attendance Registers are made through Optional courses college / school wise. Batch Sections are defined as;
    - **B.A.LL.B. (2021-26) :: Lloyd Law College**
    - **-A-B- :: Insurance Law, -C-D- :: Criminology**
    - **B.A.LL.B./B.Com.LL.B. (2021-26) :: Lloyd School of Law**
    - **-A- :: Insurance Law, -B- :: Criminology**
  - Once you have paid college fee, it will be shown in this form, hostel resident and non-resident option must also be chosen. This will take you to deposit the Hostel fee.
  - University Grants Commission Mandatory Anti-Ragging Form must have to be filled.
